6. The Artist / Label cannot use broadcast to directly sale or will not excerpt or make any other such use of "except for promotion thereof.
7. At any time SMP can rebroadcast your track on other station that is affiliate without your acknowledgement at no cost to you.
8. **SMP is not licensed by ASCAP, BMI, SESAC, and Soundexchange.**
